The significant increase from 2011-12 to 2012-13 and the decrease that followed in 2013-14 illustrate why taxpayers and policymakers should know more about what kind of students are enrolling in AOI schools. Nearly 6,000 fewer students are accounted for in the 2013-14 school year than in the prior year. The superintendent's report indicates that ADM was largely unchanged (a difference of approximately 500 ADM), yet the total student differential was significantly higher. Were these part-time students that did not complete the school year? Were these full-time students that did not complete the year? Did these students complete any coursework before they left?
