Letter from a Scholar

A decade ago, the Goldwater Institute set out to address an appalling reality: terminally ill Americans are routinely blocked from potentially lifesaving treatments by government bureaucracy.

Now, thanks to our groundbreaking **Right to Try** law, patients are escaping that nightmare. Passed in 41 states and then by Congress in 2018, Right to Try has become a literal lifesaver for people with diseases like cancer and ALS. But it's time to take the next step.

Some of the options covered by Right to Try are off-limits for the 1 in 10 Americans with a rare disease – many of them children. Innovation is outpacing regulation, and these new treatments can't get through the FDA's antiquated approval processes in time to save lives.

Following our successful Right to Try roadmap, we've already enacted "Right to Try for Individualized Treatments" in states including Arizona. Maryland, Mississippi, Nevada, and North Carolina.
