GREETINGS:

The following action was taken by the Arizona Supreme Court on June 2, 2026, regarding the above-referenced cause:

**ORDERED: Petition for Review = GRANTED as to the following rephrased issue:**

**Did the court of appeals err by failing to apply the factors this Court set out in Transamerica when it concluded that § 41-1494 provides no implied private right of action?**

**FURTHER ORDERED: Request for Attorneys' Fees (Respondent Anderson) = CONTINUED.**

**FURTHER ORDERED: The case shall be set for oral argument.**

**FURTHER ORDERED: The parties may file simultaneous supplemental briefs, not to exceed 20 pages in length, no later than June 22, 2026. Any amicus briefs are due on or before July 7, 2026 and any responses to amicus briefs are due on or before July 27, 2026. Any amicus briefs or responses may not exceed 20 pages in length.**

Filing a supplemental brief is permissive rather than mandatory.

This order is not an invitation to repeat the contents of the Petition for Review, the Response, or any Reply. Lack of a supplemental brief is not an admission that the opposing party or parties' position should prevail.

All supplemental briefs shall include a table of citations that alphabetically arranges and indexes the cases, statutes and other authorities cited in the brief and refers to the pages of the brief on which each citation of authority appears.

Counsel will be advised of the oral argument date and time when the hearing date is determined.

The Clerk of the Court of Appeals, Division One, Phoenix, must forward the remaining record to the Clerk of the Supreme Court.
