Re: Letter of Intent to Acquire Assets of Coyote Hockey, LLC and Arena Management, LLC

Ladies and Gentlemen:

Ice Edge Holdings, LLC, a Delaware limited liability company ("Ice Edge"), is pleased to present this non-binding proposal for the acquisition of substantially all of the assets of Coyote Hockey, LLC and Arena Management, LLC (collectively, the "Seller"), debtors-in-possession in Chapter 11 cases administered by the United States Bankruptcy Court for the District of Arizona (the "Bankruptcy Court"), subject to the terms and conditions set forth below (the "Transaction"). This letter agreement reflects Ice Edge's desire to participate in the auction process established by the Bankruptcy Court and promptly enter into a fully negotiated purchase agreement with Seller on the terms contemplated herein.

Ice Edge has developed a plan it believes can make the Phoenix Coyotes franchise (the "Team") and NHL hockey successful in Phoenix for the long run. While the last few years have been economically challenging ones in the greater Phoenix-Glendale region, Ice Edge believes the demographics for the region will provide a very favorable environment for NHL hockey in the long term.

Ice Edge has developed a plan to improve the marketing of the Team and its association with the greatest hockey player of all time, Wayne Gretzky, make comprehensive changes to the Team's business model, enrich the fan experience at the Jobing.com Arena (the "Arena"), and ultimately realize incremental positive changes in revenue and performance.

Potential Gretzky Partnership. Ice Edge is seeking to solidify the Team's relationship with its managing partner and head coach, Wayne Gretzky, and intends to offer Mr. Gretzky the opportunity to participate in this Transaction as a major shareholder of the newly constituted Coyotes franchise. We would hope to leverage our association with Mr. Gretzky's brand to enhance facilities both within and outside of the Arena, and to more aggressively court major corporate partnerships. Ice Edge also intends to offer Mr. Gretzky a long term coaching contract

with lucrative playoff incentives and a position on the Board that will oversee the operation of the Team and Arena.

Business Model Improvements. The Ice Edge team believes that a number of business model improvements may be implemented to make the Team a viable long term staple in the Phoenix-Glendale market. These improvements may include the following measures:

- implementing an innovative new ticketing system;
- re-evaluating the parking concession;
- aggressively seeking additional endorsement and sponsorship opportunities;
- reducing certain operating expenses by eliminating redundant costs;
- maximizing revenue sharing opportunities;
- better utilizing the Arena's existing concessions; and
- seeking NHL Board of Governors approval to allow the Team to play a limited number of home games a year in a chosen Canadian sister city.

Arena Lease. Ice Edge is prepared to enter into agreements to address the terms of the Arena lease and establish a mutually beneficial partnership with the City of Glendale ("Glendale"). Ice Edge has been in extensive discussions with Glendale and has developed specific plans that will enhance the current partnership between the Team and Glendale, which will enable the Team to remain in the Arena for the long term.

The following Transaction structure reflects Ice Edge's first steps to move the Team towards raising Lord Stanley's Cup and presenting a solvent balance sheet to the creditors and equity holders of the Team.

1. Acquisition Structure.

(a) Ice Edge is prepared to enter into an asset purchase agreement (the "Purchase Agreement") pursuant to Sections 363 and 365 of chapter 11 of the Bankruptcy Code (11 U.S.C. § 101 *et seq.*, the "Bankruptcy Code") to acquire substantially all of the assets and assume substantially all of the liabilities necessary to (i) operate the professional hockey team known currently as the Phoenix Coyotes as an NHL franchise and (ii) the right to operate and manage the Arena (the "Business").

(b) Ice Edge's proposal contemplates that prior to the closing date of the Transaction (the "Closing Date"), Ice Edge will (i) acquire those assets and contracts necessary to operate the Business except for those assets and contracts designated by Ice Edge as excluded items (the "Purchased Assets"), which shall be free and clear of any and all interests, liens, claims, charges or encumbrances and (ii) assume specified liabilities necessary to operate the Business, as identified by Ice Edge (the "Assumed").

Liabilities”). The Purchased Assets will include those assets and contracts identified on Exhibit A. Seller will deliver the Purchased Assets as of the Closing Date.

2. Purchase Price.

(a) The purchase price for the Purchased Assets to be sold to Ice Edge will be an amount not to exceed \$150,000,000 consisting of: (i) \$10,000,000 cash escrow deposit; and (ii) up to \$140,000,000 of additional cash payments or assumptions of Assumed Liabilities on the Closing Date (the “Purchase Price”).

(b) The Purchase Price is inclusive of the amounts necessary to assume the unpaid amounts or unsatisfied obligations which must be discharged in order for Ice Edge to assume the executory contracts of the Business pursuant to Section 365 of the Bankruptcy Code.

(c) The Purchase Price assumes that other than Seller and its subsidiaries, there are no other individuals or entities that own or operate any of the assets necessary to conduct the Business. The Purchase Price also assumes that the Business will be delivered at closing with sufficient working capital for its operational requirements.

(d) Upon the execution of the Purchase Agreement, ten percent (10%) of the Purchase Price will be placed in a third party escrow account (the “Escrow”) and used as a source of payment for Seller’s post-closing obligations with respect to any negative Purchase Price adjustment or indemnification claim relating to a breach of representations or warranties (subject to customary exceptions). Amounts remaining in the Escrow 18 months after the closing date will be released to Seller (except to the extent of any pending claims).

3. Purchase Price Adjustments. The Purchase Price will be:

- (i) reduced by the amount by which the net working capital of Seller as of the Closing Date is less than the target amount of net working capital necessary for Seller or such subsidiaries to meet its operational capital requirements;
- (ii) reduced by the amount of cure costs to transfer to Ice Edge those contracts specified by Ice Edge as Purchased Assets (“Acquired Contracts”) pursuant to Section 365 of the Bankruptcy Code;
- (iii) reduced by any obligation or expense incurred after the date of the Purchase Agreement and outside of the ordinary course; and
- (iv) reduced by any claims or liens not discharged pursuant to Section 363(f) of the Bankruptcy Code.

An estimate of the foregoing adjustments will be made on the Closing Date based on the parties agreed upon estimates. The estimated adjustment will be subject to a customary post-closing “true-up” pursuant to a dispute resolution mechanism to be agreed upon.

4. Financing. Ice Edge will finance the payment of the Purchase Price and transaction expenses through a combination of debt and equity financings. Prior to the Closing Date, Ice Edge will have, sufficient funds available to pay the Purchase Price, and any expenses incurred by Ice Edge in connection with the Transaction.
5. Employees. Ice Edge presently intends to assume, either in their current form or as amended, all rights of Seller under contracts for (i) the employment of all Team players which are parties to standard player contracts with Seller on the Closing Date (the "Assumed Player Contracts"), (ii) the rights to Team players who are not under contracts with Seller, and (iii) the employment agreements of the coaches, trainers, scouts, announcers, front office personnel and other non-player employees of the Team and/or Arena, as designated by Ice Edge.
6. Due Diligence. We are in the process of completing our due diligence review. Upon our selection as a Qualified Bidder (as defined in the Bidding Procedures Order entered by the Bankruptcy Court on July 6, 2009), we will conclude our legal and accounting due diligence. We would expect to have access to senior management and Seller's counsel and accountants during the process. We will also need to complete the following reports:
 - (i) review of the financial statements of Seller and its affiliates;
 - (ii) disclosure of the cure amounts to be payable in connection with assumption and assignment of the Assumed Player Contracts and the Acquired Contracts;
 - (iii) disclosure of the nature of Seller's interest in 3051349 Nova Scotia Company;
 - (iv) disclosure of the nature of any proposed amendment, modification, termination or compromise of any Acquired Contract; and
 - (v) cooperation of Seller with diligence regarding tax related issues to structuring the most efficient tax vehicle structure for transfer of the Purchased Assets.

We estimate that it will take one to two weeks to complete our confirmatory due diligence and receive and analyze the financial and legal reports, and we are prepared to commence work on these matters in parallel with negotiating the Purchase Agreement. The Purchase Agreement will not contain any due diligence contingencies.

7. Conditions. The Transaction would be subject to the prior satisfaction of customary conditions precedent, which shall include (without limitation):
 - (i) the negotiation of a definitive Purchase Agreement acceptable to Ice Edge;
 - (ii) receipt of the proceeds necessary to consummate the Transaction pursuant to financing agreements acceptable to Ice Edge;

- (iii) receipt of all material third party and governmental consents (including, without limitation, Hart-Scott-Rodino approval) and any consents required by the NHL;
 - (iv) the execution of acceptable employment agreements with certain key members of the Team's management;
 - (v) the approval by the NHL of the Transaction under all of the NHL's applicable ownership transfer requirements, including, without limitation, as set forth in Articles 3.5 and 3.6 of the NHL Constitution, By-Law 35, including negotiation, execution and delivery by Ice Edge, and the NHL of an NHL Consent Agreement and an NHL Guaranty, in each case acceptable to such parties;
 - (vi) the entry by the Bankruptcy Court in accordance with Section 363 of the Bankruptcy Code of a non-appealable final sale order containing terms acceptable to Ice Edge; and
 - (vii) the negotiation, execution and assignment to Ice Edge of the Acquired Contracts on terms and conditions satisfactory to Ice Edge and the third parties that are parties thereto.
8. Covenants; Representations and Warranties. The Purchase Agreement will contain customary covenants, representations and warranties for a transaction of this nature including, without limitation, the following:
- (i) mutually acceptable purchase price adjustment and indemnification provisions consistent with the terms set forth herein;
 - (ii) representations with respect to the organization, title to assets, financial condition of Seller, and absence of conflicts with respect to the Transaction;
 - (iii) covenants with respect to operating the business in the ordinary course, capital expenditures and working capital management; reasonable assurances; obtaining the approvals of the Bankruptcy Court and the NHL; and access to the books and records of Seller; and
 - (iv) representations as to no material adverse change in the Business, its assets, liabilities or prospects.
9. Indemnification. Seller will be obligated to indemnify Ice Edge against all losses relating to breaches of representations, warranties and covenants in connection with the unreleased liens on the Purchased Assets, as set forth in the Purchase Agreement, subject to a tipping basket and capped at the amount of the Escrow (provided that such basket and cap shall not apply to claims related to fraud or willful misconduct). The representations and warranties of Seller will survive until 18 months following the Closing Date.

10. Termination. This letter agreement will automatically terminate and be of no further force and effect upon the earliest of (i) execution of a definitive Purchase Agreement, (ii) mutual agreement of Ice Edge and Seller, and (iii) August 10, 2009. Notwithstanding anything in the previous sentence, paragraphs 10, 12, 14, 16 and 17 shall survive the termination of this letter agreement and the termination of this letter agreement shall not affect any rights any party has with respect to the breach of this letter agreement by another party prior to such termination.
11. Expiration. This offer will remain in effect until the earlier of (i) the execution by Sellers of a Purchase Agreement and (ii) five (5) days following the date of the sale hearing to be conducted by the Bankruptcy Court or otherwise extended or terminated in writing by the undersigned prior to its acceptance by Seller.
12. GOVERNING LAW. THIS LETTER AGREEMENT SHALL BE GOVERNED BY AND CONSTRUED IN ACCORDANCE WITH INTERNAL SUBSTANTIVE LAWS OF THE STATE OF NEW YORK, REGARDLESS OF THE LAWS THAT MIGHT OTHERWISE GOVERN UNDER APPLICABLE PRINCIPLES OF CONFLICTS OF LAW OR CHOICE OF LAW.
13. Access to Information. Seller shall afford, and cause their respective affiliates, officers and agents to afford, to Ice Edge and its co-investors and agents (the "Representatives") full and complete access to Seller's and its subsidiaries' properties, business, personnel, and financial, legal (except as may be required to maintain the attorney/client privilege), tax and other data and information as reasonably requested by Ice Edge or its Representatives.
14. Expenses. Ice Edge and Seller shall each bear their own respective transaction expenses, including fees and expenses of legal counsel, investment bankers and other advisers, incurred in connection with the Transaction, unless otherwise ordered by the Bankruptcy Court.



Purchased Assets

Subject to further due diligence, the Purchased Assets shall include the following:

(a) all cash, cash equivalents, bank deposits or similar cash items and accounts receivable of Seller and its subsidiaries other than any accounts receivable arising out of or in connection with any excluded assets;

(b) The Team's NHL franchise and Seller's membership interest in the NHL and all NHL entities that are jointly owned by all member clubs of the NHL and all other rights, privileges and benefits granted to a member club by the NHL;

(c) all items of tangible personal property and fixtures owned by Seller and Seller's interest in all items of tangible personal property and fixtures leased by Seller and, in either case, used in connection with the Business or the Arena, including, without limitation, furniture, fixtures, furnishings, equipment including hockey, exercise and weight training and medical equipment, computer hardware and software and related materials, audio-visual equipment, scoreboards, static and non-static signage, machinery, office supplies and equipment, telephone systems, instruments supplies, inventory, automobiles and other vehicles, Zamboni ice resurfacing machines;

(d) those amounts which have been accrued but not yet paid by the NHL to Seller in connection with the Business as of the Closing Date;

(e) all intellectual property owned by or licensed by Seller and all licenses of intellectual property held by Seller and used in connection with the Business or the Arena, including, without limitation, all associated trade names, proprietary product names, service marks, logos, trademarks, and the goodwill associated therewith, and all copyrights, trade secrets, and confidential business information (including ideas, research and development, know-how, formulas, compositions, manufacturing and production processes and techniques, technical data, designs, drawings, specifications, customer and supplier lists, pricing and cost information, and business and marketing plans and proposals), patents, patent applications, inventions, know-how (whether or not patented, patentable or already reduced to practice), the Team's interest in its website, website domain names, and all off-the-shelf software and Seller's rights therein;

(f) licenses, permits and other governmental authorizations incidental to the operation of the Team or the Arena, to the extent assignable by law;

(g) all books and records of Seller relating to the Business;

(h) all rights of Seller under the Assumed Player Contracts and rights to Team players who are not under Assumed Player Contracts;

(i) all rights of Seller under the agreements related to providing Team or Arena sponsorship rights to third parties following the Closing Date, agreements for use of Arena suits, premium club seats and season tickets following the Closing Date, agreements for use of the Arena to present entertainment events following the Closing Date, employment

contracts for players on the roster of the Team as of the Closing Date, employment contracts for coaches, trainers, scouts, announcers, front office personnel and other non-player employees of the Team and/or Arena designated by Ice Edge, the Team's minor league affiliate agreement, the Team's radio broadcast agreement and vendor Contracts for the Arena and the Team;

(j) all insurance benefits, including rights and proceeds, arising from or relating to the Purchased Assets or the Assumed Liabilities prior to the Closing Date;

(k) all other intangible assets of Seller relating to the Business or the Arena, including all goodwill associated with the Business;

(l) all of Seller's interest in 3051349 Nova Scotia Company, a Nova Scotia unlimited liability company;

(m) all rights of Sellers under non-disclosure or confidentiality, non-compete, or non-solicitation agreements with employees and agents of Seller or with third parties to the extent relating to the Team or the Purchased Assets (or any portion thereof); and

I thought you might be interested to know that I had a packet waiting for me in the mail when I got home this evening from attending the hearing. It's from Jerry Moyes' attorney and details his objections to Mr. Reinsdorf's bid, complete with emails supporting the claims. I checked around with several of the other season ticket holders and they received the same packet in the mail. This is the second letter the season ticket holders have gotten in the mail from Mr. Moyes recently. The first was a letter telling season ticket holders to submit their claims as unsecured creditors so that we could be paid back for the money we'd spent on our season tickets prior to the bankruptcy filing on May 5th. This lead some STH's to believe that the money they'd paid since then would not be returned to them. As you can imagine, the fans are developing some concerns as to whether or not they should invest in purchasing tickets at this point, in addition to the concerns they'd had prior to receiving these documents. I thought this should be brought to your attention, in case you are not already aware of it.

Thank you for your help. I was finally able to listen to the channel 12 news story from Sunday night.

Brahm left out one word when he took my comments from July 14 and used them in his August 3 story. That word is "probably". What I said on the tape is, "That's probably far beyond anything we would be willing to do regardless of our means".

The one word, "probably" takes my statement from one that is spoken as a sure thing – as in it has been discussed and the council has determined its feelings ----- to what I was really doing, expressing my opinion.

Also, another thing that is totally wrong with Brahm's article is that there was no knowledge on my part, nor his, on July 14 that Jerry Reinsdorf has asked City of Glendale management for a taxing district that would guarantee him \$23 million per year at a rate of up to 11.5 cents tax on all sales, a guarantee that the City of Glendale would pay Reinsdorf \$15 million per year if the team was still losing money after five years, and that if the City of Glendale refused to pay the \$15 million per year then Reinsdorf could sell/move the team.
